In attention to the Official Letter, the Company clarifies that is not aware of any undisclosed act or fact that may justify the oscillations verified in relation to the price, traded quantity, number of trades, and the volume traded with its shares

In compliance with article 4, sole paragraph, of CVM Resolution No. 44, of 2021, the Company questioned its managers and controlling shareholders about the existence of undisclosed acts or facts capable of justifying the fluctuations verified, and they confirmed that they were not aware of any information with such potential.

As these considerations are deemed relevant in relation to the Official Letter, the Company is available to provide any additional clarifications that may be necessary.
